Artist/Craftsperson Requirements

- The Bellefonte Arts & Crafts Fair is a **JURIED** event and takes place on Allegheny & High Streets in downtown Bellefonte, PA
 - All items must be handmade and original products of the applicant.
 - No manufactured, imported, buy & sell items, kits, or pre-cut components.
 - Only items produced by the artist and approved by the Jury Committee may be sold at the Fair.
 - Violation of any of these requirements may result in a request for the artist to remove unapproved items or to leave the Fair.
- Spaces will be assigned and are limited to a 10' x 10' area for a single space; 10' x 20' for a double space.
- Please note that some street areas are not all flat and are on a slant. You may wish to use leveling boards/shims. Exhibitors are required to furnish all equipment and display needs including canopies, tables, & chairs. Canopy sides, weights, & risers are strongly advised. **BE PREPARED FOR ALL WEATHER.** This is a rain or shine event.
- Please note that there is no parking at your booths so plan for retrieving stock items during the Fair hours.
- Artists must attend both days of the Fair and remain open during the event hours of Friday 10-8 and Saturday 10-5.
- Set up time: Booths must be set up and ready to go by 10 a.m. on Friday, August 2nd 2024. Set-up Thursday evening, August 1st is strongly encouraged.
- PA Sales Tax Licenses are required to be displayed when exhibiting.
- NO electricity will be provided, and only quiet generators permitted.
- Musical entertainment will be provided throughout the day therefore we ask that no music be played in your booth area unless using headphones.
- No direct sales companies, wholesale companies, or political organizations are permitted nor is anyone or any entity or business permitted to setup a display, booth, or distribute information, petition, or have sign-ups without express written consent of the Bellefonte Arts & Crafts Fair Directors.

Application & Fees

- All applications & fees must be received by **May 1, 2024** due to printing deadlines of our event guide & advertising.
- All applicants must send four representations of the artist's work and one of booth set up in a jpeg file sent via email for jurying. Photos may also be used for promotional purposes. Faded or blurry images will not be accepted. Include your last name as part of the file name so they can be matched to your application.
- Checks for Registration Fee made out to **Bellefonte Arts and Crafts Fair** (no credit cards)
 - **\$150** regular registration fee per single space due with application by May 1, 2024
 - **\$175** late registration fee per single space for applications postmarked after May 1, 2024 with no guarantee your name will be included in our event guide.
 - A fee of \$40.00 will be applied to all checks returned for insufficient funds.
 - Beware of scammers!! As stated above, we only accept checks and mailed with application to our PO Box.
 - Please **do not staple** anything to the application.
 - Any vendor serving alcohol must provide a copy of your liability insurance with your application.
- **Application fees are non-refundable** unless the event is cancelled by the Fair Committee.
- Application fees are deposited upon receipt, but this is not your guarantee of acceptance. After the Jury Committee reviews the applications and photos, a letter of acceptance or rejection will be sent via email. If you are not accepted into the Fair, a refund check will be issued.
- Previous acceptance to the Bellefonte Arts & Crafts Fair is not a guarantee of acceptance for the 2024 Fair.
- **Bellefonte Arts & Crafts Fair is not responsible for lost or misdirected email.**

- Judging takes place on Friday, August 2nd and award plaques in the art categories listed on Page 1 are given at the discretion of the Bellefonte Arts & Crafts Fair Jurors.
